





Impact


HCAC training services impact healthcare providers in the public and private sector throughout Jordan by focusing on:

- Through Ejawda platform, HCAC keeps moving alongside the future of virtual training models and meets HCAC vision.



Research on the Impact of Accreditation & Organizational Readiness & Reform

About Program:

Research and Impact analysis paves the way forward

Healthcare Accreditation Council (HCAC) has done several research to study the impact of the main activities implemented in different healthcare organizations. The impact of many crucial aspects was covered in the research done: quality and safety trainings, implementation of accreditation, 2nd time accreditation and enhancing compliance with standards, assessment of hospitals readiness to respond to COVID-19, applying HCAC standards in public sector, HCAC surveys site visits and documentation and incidence reporting, just to mention a few. For accreditation, the most impacted and influenced areas are: patient safety, client focus, infection prevention, environmental safety and human resources.

Methodology:

Al-Bashir Hospital (ABH) is the largest public hospital in Jordan, and here it is taken as an example to summarize the study done for the journey of the hospital in getting HCAC accreditation:


-The analysis used data generated from initial assessment, interim assessment and mock survey the comparison between them will demonstrate the progress achieved in 5 hospitals related to ABH.

-The aim was to describe the journey alongside with the challenges and lessons learned.

-The recommendations outcome from this study will provide guidance to the policymakers on how to prepare the public and private sectors for accreditation and how to become more efficient.

Facts:


- -4.4/5 participants satisfaction rate with quality and safety trainings.
- -From 16% to 96% improvement in medical records after accreditation.
- -Infection prevention and sterilization have jumped up to 96% & 98% after compliance to standards.
- -Diagnostic standards reached an average of 95%.
- -Environmental safety reached 93%.
- -Human resources and leadership reached 93%.



Impact

-It was clear from the study analysis related to ABH that the overall compliance score has greatly improved over the project period. Also, the compliance rate per standards category has significantly increased in all the hospitals throughout the activity period. -Nonetheless, several lessons were learned during this project that contributed to raising the commitment of ABHs employees towards quality and patient safety and achieving remarkable progress towards fulfilling the accreditation requirements.
